Portfolio Allocation

For the month of March, the portfolio adopted an extremely defensive posture, leaving it 100% invested in U.S. T-Bills.

In terms of performance attribution, the portfolio's T-Bill exposure rose 0.4%, which in the Canadian dollar class of units was offset by an appreciation of the Canadian dollar vs. its U.S. counterpart.

The portfolio has since maintained its risk-off mode, with a 100% weighting in U.S. T-Bills.
