Investment Strategy and Objectives

The Outcome Country Rotation mandate focuses primarily on emerging market equities. The strategy uses a data-driven, machine learning-based approach to invest in large, liquid ETFs, with the objective of delivering superior long-term returns.

June 2023, Year-to-Date and Inception-to-Date Results

For the month of June, the Country Rotation strategy rose 5.1%, as compared to a decline of 4.4% for the MSCI Emerging Markets Index.

On a year-to-date basis, the strategy is up 8.2%, as compared to a gain of 5.2% for the MSCI Emerging Markets Index.

Since its inception in January 2021, the strategy has declined 11.0%, as compared to a decline of 19.1% in the MSCI Emerging Markets Index.

Portfolio Allocation

During the month of June, the portfolio was equally-weighted across South Korean, Taiwanese, Brazilian, Eurozone, and Japanese equities.

In terms of performance attribution for the month, the portfolio's exposure to South Korean stocks rose 1.0%, its position in Taiwanese shares advanced 18%, its allocation to Brazilian equities rose 15.1%, its position in Eurozone companies was up 4.3%, and its Japanese exposure gained 5.0%.
